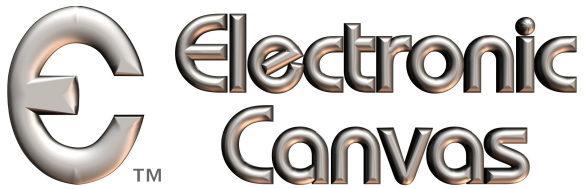

Illegal content:

Privacy Policy:

Video content on tapes or other media may be provided to Electronic Canvas Ltd. This video will be processed by employees of Electronic Canvas Ltd. who may view the content to assure quality and ascertain the starting and ending points of the process. The content of your video may be temporarily stored on removable or stationary media during the video transfer process. Electronic Canvas Ltd. may retain these files for a period of time to enable additional copies to be created without the need for transportation of the original.
